C. Executive Director's Annual Review

Dr. Rostock reviewed the Executive Director's 2014 performance and requested the inclusion of his review in the District's record. It follows below.

# **Executive Director – 2014 Review**

Dr. Arrington's 2014 performance was excellent, and his leadership skills served the District very well.

Some of Albrey's noteworthy accomplishments in 2014:

- ✓ The District is now debt free;
- ✓ Successfully negotiated the Interlocal Agreement between Jupiter Inlet Colony, the District and The Village of Tequesta for Joint Participation and Project Funding of the Jupiter Inlet Colony Neighborhood Rehabilitation.
- ✓ Obtained \$600,000 LRPI grant for JIC Neighborhood Sewering project;
- ✓ Empowers existing District staff to maximize their contributions to the District (e.g., complete shutdown of the plant to conduct necessary inspections and upgrades);
- ✓ Systematically improving the reliability of our collection system (i.e., replaced right-of-way PVC y-check valves in the low pressure forcemain system);
- ✓ Selected new auditors, and maintained a clean audit in 2014;
- ✓ Hosted Governor Scott at the River Center: and
- ✓ Maintained strong, collaborative partnership with Busch Wildlife Sanctuary in 2014.

# Some challenges Albrey faced in 2014:

- ✓ Brought two pending legal matters to successful conclusion through Mediation
- ✓ Lack of progress implementing the new Computerized Maintenance Management System;
- ✓ Addressing Martin County's Comprehensive Plan Amendment prohibiting sewers in SUSD; and
- ✓ Cancel and re-bid Landscape Maintenance Services Contract.

Albrey is respected among his peers, which serves the District well.

- ✓ Used our water quality data to work with Town of Jupiter to implement safeguards in the development order for Lakewood to minimize pollution of the Wild and Scenic Northwest Fork of the Loxahatchee River;
- ✓ Invited to participate in panel discussions and technical workshops:
  - WateReuse's International Panel of General Managers of Leading Reuse Systems;
  - American Water's workshop to "Develop Best Management Practices to Control Potential Health Risks and Aesthetic Issues Associated with Storage and Distribution of Reclaimed Water":
- ✓ 2014 was Albrey's third term as Chair of the Technical Committee for the Annual WateReuse Symposium an international symposium advancing the beneficial use of reclaimed water.
- ✓ Albrey serves on a number of important local committees that affect the health of the Loxahatchee River and surrounding waters:
  - Chair, Loxahatchee River Management Coordinating Council
  - SFWMD Water Resources Advisory Committee
  - Loxahatchee River Preservation Initiative; and
  - Advisor to Ocean Research & Conservation Association's Indian River Lagoon study.
