MATERIALS TESTING SERVICES CONTRACT SUBJECT:

The District regularly uses materials testing services on our construction projects, either for our own construction crews and Engineering Department projects or small consultant projects. This testing typically consists of obtaining densities of soils, or concrete testing.

These services are covered by the CCNA selection process, which Jupiter has recently completed for "Construction Materials Testing Services".

The attached letter from GFA approves District use of the Jupiter Contract. The Town has also consented to the District piggy-back of their contract. Individual purchase orders will be issued for specific projects and are billed according to the actual tests. The Contract provides more specifics and is available for review upon request.
