CENTER ST. GRAVITY REHABILITATION

In September, 2014 the Governing Board approved a contract with LMK Pipe Renewal, Inc. for insitu-repairs (no digging) to the sewer service lines on Center Street. A proposal using contract prices from the City of North Miami Beach was piggy-backed for the service repairs. The total contract was estimated to be \$155,525.00. The service repairs have been completed and the expense reduced significantly by District engineering and construction personnel's installation of clean-outs to determine the extent of repairs needed.

However, during the inspections of the system two other areas were identified as being in need of repairs. While, these areas were not included in the original proposal, Mr. Dean worked with the contractor to get pricing information for the additional work (see LMK proposal dated July 15, 2015). Because the unit prices for the additional work were actually lower than the rates from the piggy-backed contract and because the contractor was mobilized on-site and the work was on-going, and because the work would be completed in an amount less than the cumulative total authorized in the Board-approved Purchase Order; therefore, Mr. Dean authorized LMK to complete this additional work.

At this time staff requests that the Governing Board approve Change Order #1, which will rectify the units of work actually completed, and leave the not to exceed amount of the Purchase Order unchanged.

The following motion is suggested for award of this contract:

"THAT THE DISTRICT GOVERNING BOARD authorize Change Order #1 to the Center Street Gravity Rehab contract with LMK Pipeline Renewal Inc., in accordance with their proposal dated July 15, 2015, and in an amount not to exceed \$22,260.00; and the total contract not to exceed \$155,525.00."
