ACTION REQUEST: Authorization for the purchase of software license upgrade and first year of software maintenance of our Computerized Maintenance Management System (CMMS).

DESCRIPTION:

The proper and efficient maintenance and management of our assets and infrastructure are essential for providing cost effective and reliable service to our customers. Computerized Maintenance Management Systems (CMMS) are powerful tools that enable staff to effectively and efficiently manage and utilize data related to our assets. CMMS solutions offer a variety of services including asset maintenance scheduling, inspection data record keeping, document management for assets and inspections, inventory and purchasing management, as well as integration with other data systems including SCADA, GIS and accounting systems.

Our present CMMS, named Maintenance Professional 2 (MP2), is not meeting our needs because it lacks key capabilities for data storage, work order management, integration and efficiency of use. Further, the software company, Infor Inc., is no longer developing MP2. However, Infor is offering a greatly reduced price to upgrade our MP2 licenses to their successor product named Enterprise Asset Management (EAM). This software upgrade is the first step towards the gradual and incremental configuration and data migration into the new system through the upcoming year. Because we are taking a gradual, step-by-step approach to this continuously evolving system, we will likely bring requests for the purchase of additional software licenses and consulting services over the next several years.

We believe this new CMMS will provide us with significant improvements to the efficiency of our organization, and provide valuable benefits to our asset and data management. Therefore, we suggest the following motion:
